NOTES:

Membership contribution is P150.00 per month, through salary and pension deduction.

Members who reach the age of 80 are exempt from payment of monthly membership contribution.

Loan applications must be certified by the G3 head, or its equivalent.

The Co-maker must be of the same pay grade or higher. No two (2) members shall act mutually as co-makers of their loans.

Non-pensioner retirees may apply for loan up to a maximum amount of **P50,000.00** subject to more specific guidelines.
